ITEM I

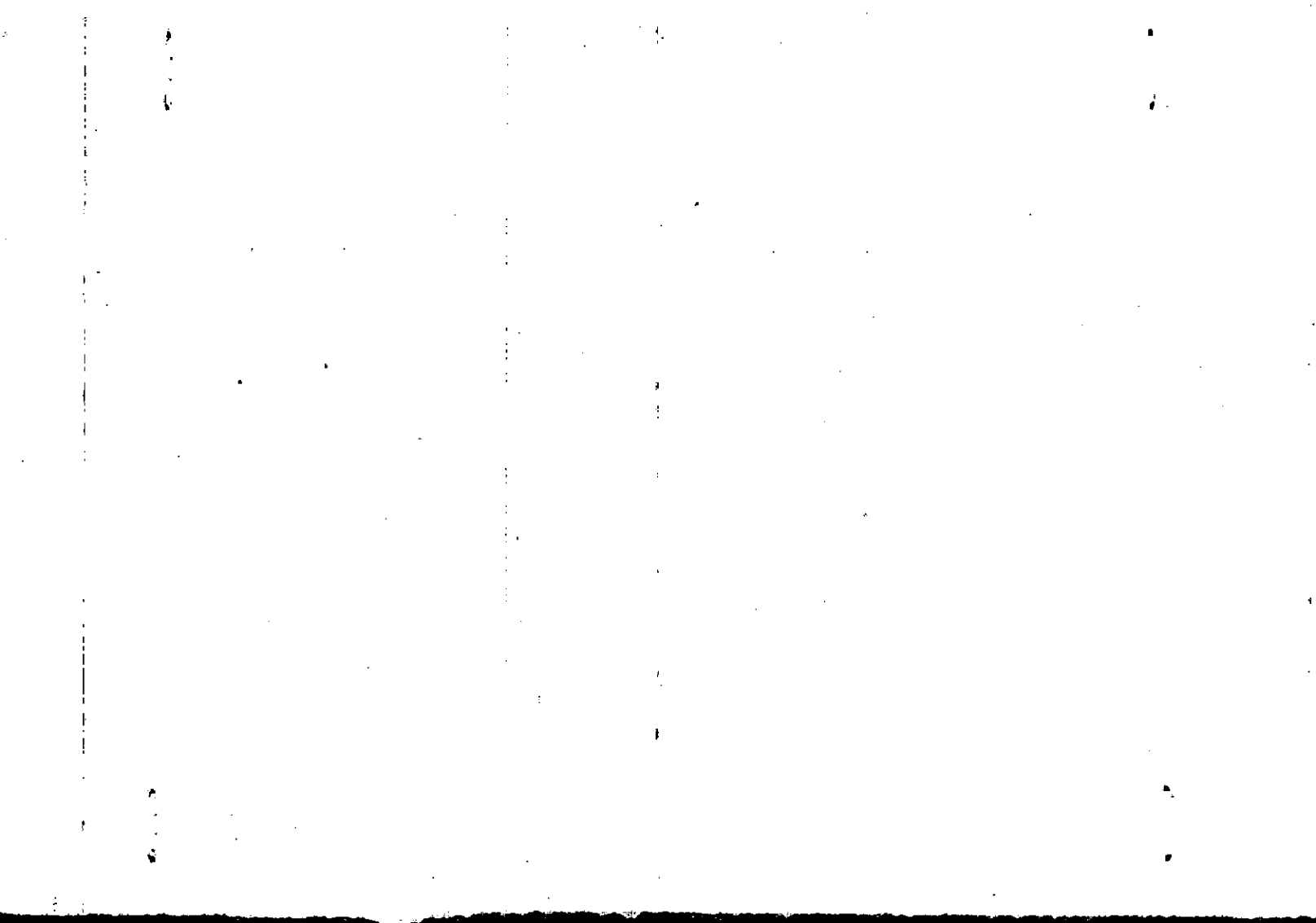
