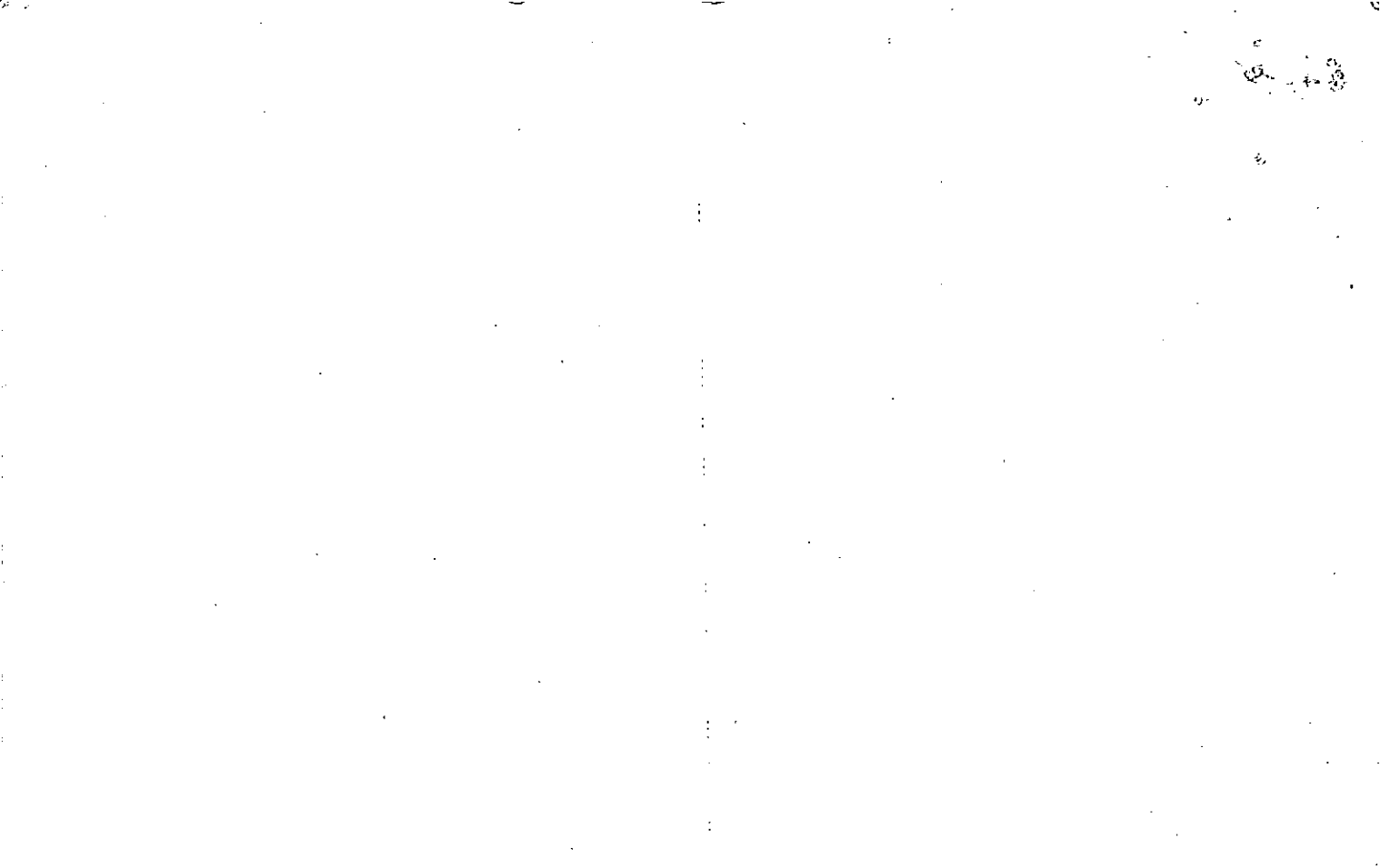

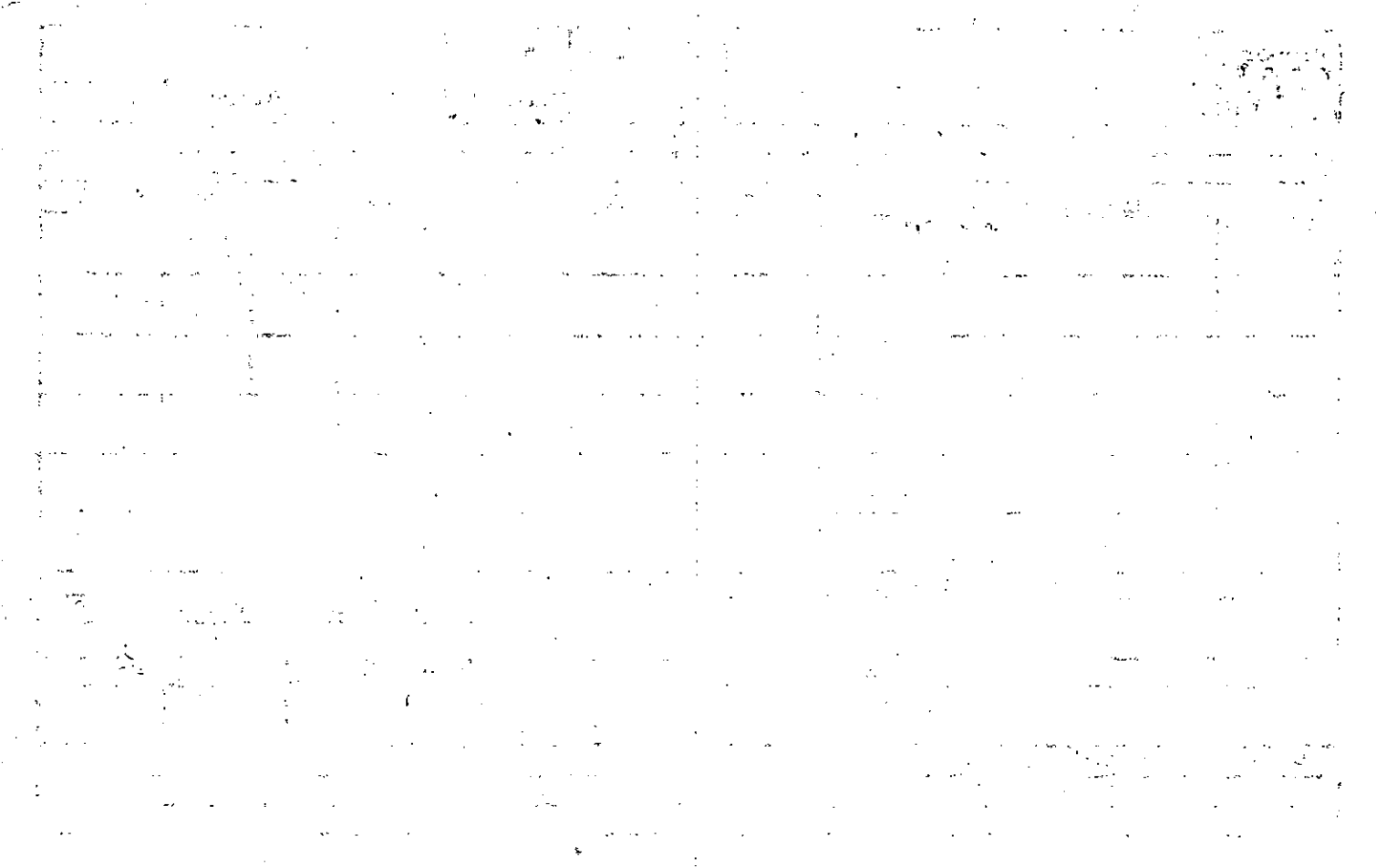

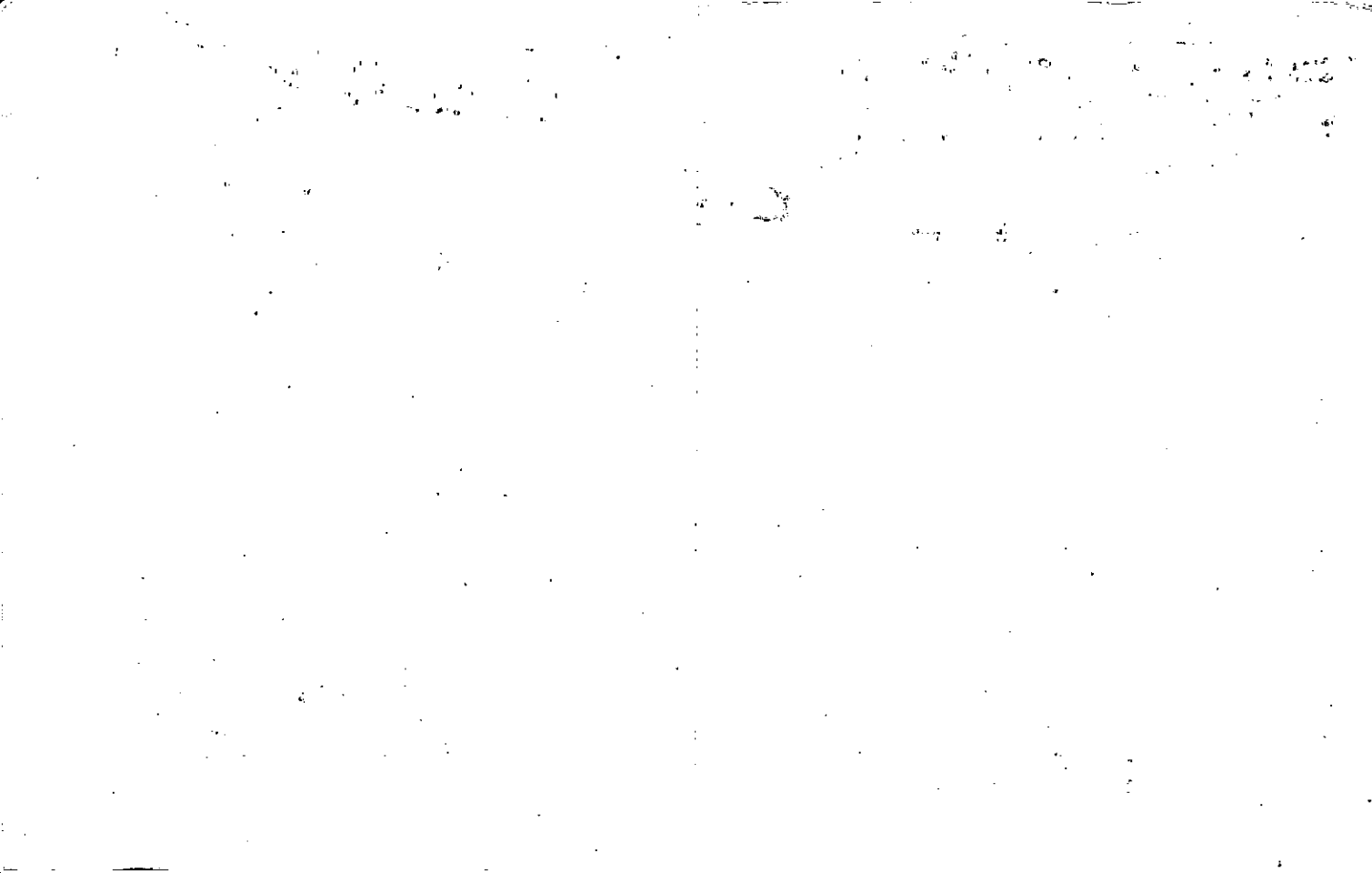

3. I represent the Owners and have been making the tax payments on the Mineral Rights on behalf of the Owners for several years.

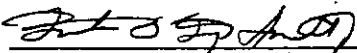

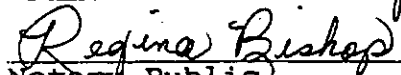

The above referenced tax parcel (hereafter, the "Tax Parcel") encompasses all of 88 land lots and portions of an additional 12 land lots. For the past several years the mineral interests in 1590 acres in the Tax Parcel have been returned for taxes in the name "Hinds, Smith & Knight." A copy of the tax card for "Hinds, Smith & Knight" (hereafter, the "Tax Card") is enclosed.

The Tax Card contains a notation to the effect that on September 8, 1971, Mr. Tony Smith identified the acreage of mineral interests covered by the Tax Card as comprising 80 acres on Map 21-1, 1460 acres plus 1/2 interest of 60 acres on Map 21-2, and 1/2 interest of 40 acres on Map 21-8.

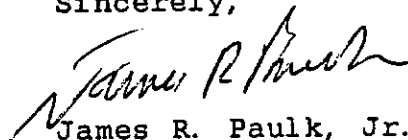

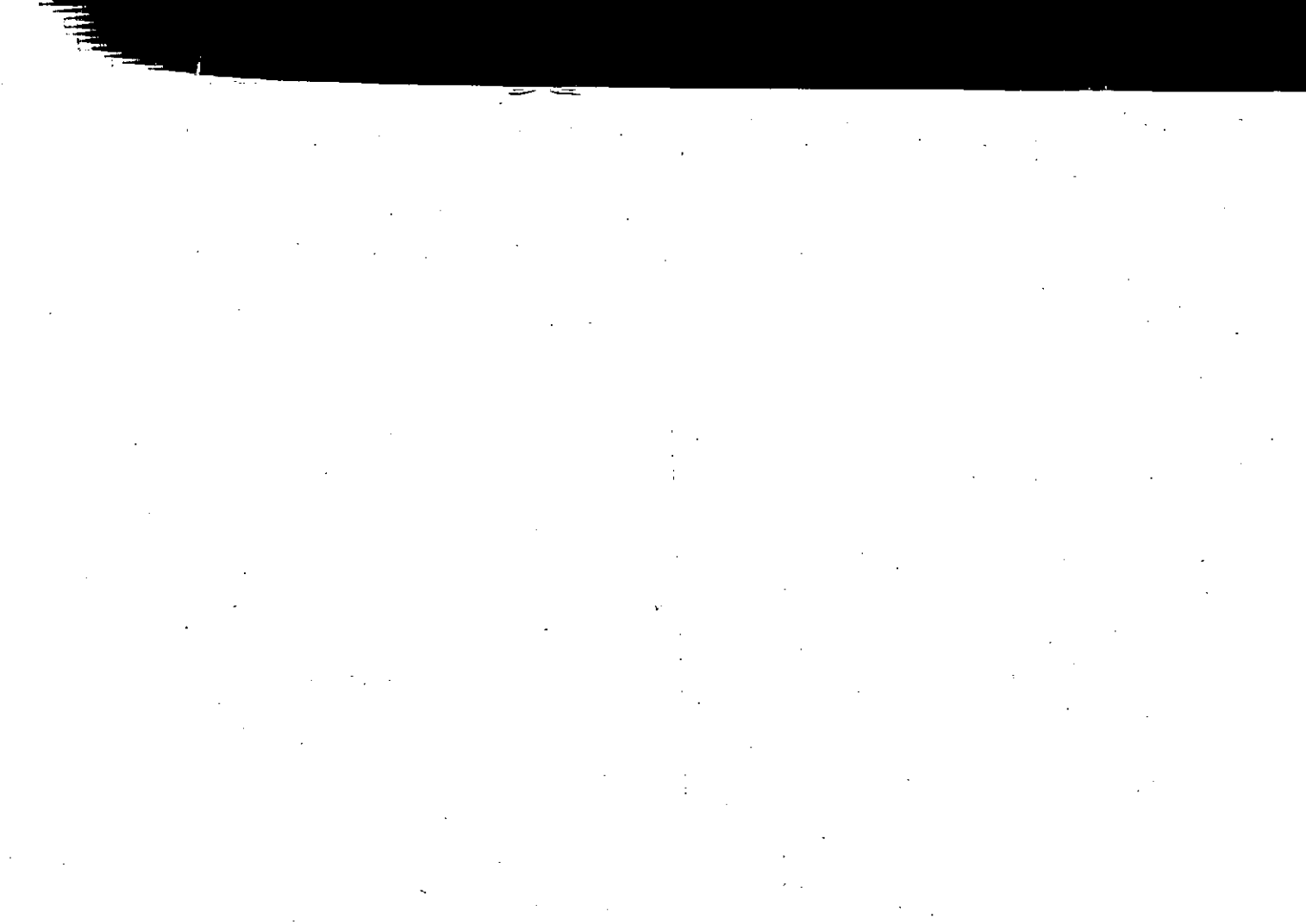

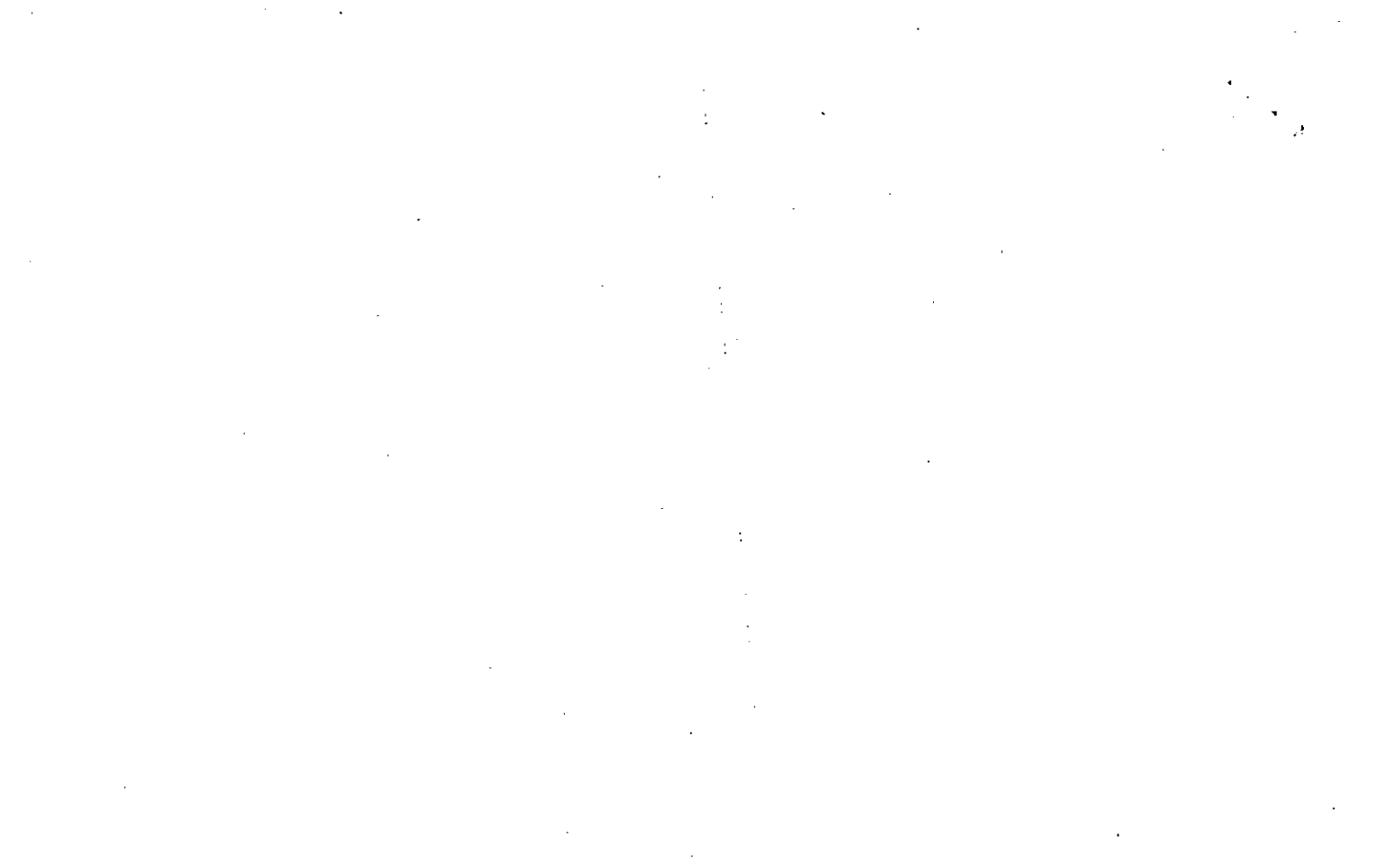
